ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

*** A Pomeranian # 620006 had matted fur around the feet, and anal region. There was fecal debris caught in the fur around the anus. Matted fur pulls and separated from the skin and can cause painful skin irritations. This dog should be groomed and the matted fur removed to prevent any skin conditions.

*** A Pekingese # 67689 has fecal debris trapped in fur around the tail and along the hind legs. Additionally the dog gave birth several weeks ago but still appears to have some irritation and drainage coming from the vulva that should also be assessed by the veterinarian for proper diagnosis and treatment.

*** A Pomeranian # 367827 had matted fur around the feet, and anal region. There was fecal debris caught in the fur around the anus. Matted fur pulls and separated from the skin and can cause painful skin irritations. This dog should be groomed and the matted fur removed to prevent any skin conditions.

INDOOR HOUSING FACILITIES.

*** At the time of the inspection approximately 2:30 pm, the ambient temperature outdoors was 91 deg F and the temperature in the kennel according to the facility's thermometer was 88 deg F read at approximately 3:00 pm. The temperature did not drop in the kennel by the end of the inspection period about an hour later and remained at 88 deg F. There were fans running in the kennel, but no method to cool the facility down to 85 deg F within the 4 hour time period. The outdoor temperature was not going to drop below 86 deg F until after 8 pm according to local weather. A majority of dogs were panting in the kennel area and the inspectors felt overheated. A method for cooling the kennel needs to be addressed to maintain temperatures for the health of the dogs.
